Agenda: Discussion on challenges before the community and the way forward.

#### **Introduction:**

The meeting was held by IMPAR on its 3rd foundation day. The purpose of the meeting was to discuss the current challenges and the possible way forwards, for the organisation to continue making a positive impact in the community. Many Eminent speakers attended the meeting and shared their valuable insights.

#### Some of the points that were discussed:

## 1. Madras's Teacher Training:

One of the points stressed in the meeting was the importance of providing teacher training to Madras's in the community to improve the quality of education. The speakers suggested that Impar should organise workshops and training programs to provide teachers with the necessary skills and knowledge.

#### 2. Youth Leadership:

The speakers emphasised the need to promote youth leadership in the community. It was suggested that IMPAR should organise dialogues with youth district-wise to identify potential leaders and provide them with training and opportunities to develop their leadership skills.

## 3. Compile Success Stories of Muslims:
