


Indian Muslims are at the crossroads, facing a plethora of challenges, from low representation in education and employment, to increased social, political and economic marginalisation. The community also faces challenges in cultural identity regarding the image and perception of Indian Muslims, which can affect their physical safety and security, and even their access to basic amenities and social welfare programs. The negative global developments also have an adverse impact on the community's image and wellbeing.

Widening the educational and economic opportunities in a cost-effective manner for its citizens is a national goal. We can only achieve positive changes for the community through internal reforms, approached with a modern outlook and increased positive social actions. And through the development of a favourable social and political environment, the community should be able to have greater access to educational and economic opportunities. Herein lies the need for the creation of a forum for research, monitoring, dialogue, coordination, engagement and data based policy advocacy and opportunity access programs for the Indian Muslim community.

IMPAR is the result of this long-felt need. However, its creation in April 2020 was an emergency response to deal with the Corona crisis, when over 500 prominent Muslims from different walks of life came together and founded it. IMPAR is working as the apex level national body for research and advocacy, strategic planning, coordinated actions, monitoring and response system and as development catalyst for Indian Muslims. IMPAR has delivered on all key challenges since its formation, and hopes to further accelerate its pace of delivery and performance.

The challenges before us are many. We have taken the first step. And as Mahatma Gandhi said, "You must be the change that you wish to see around". I am confident IMPAR over the years will develop into a powerful institution to steer the community towards the path of progress and reforms, and help to usher in an era of peace and prosperity across our country. 
To empower the Indian Muslim community to contribute to the society and the nation

## SCOPE

Muslims in India number approximately 200 million, representing roughly 15% of the population, but their share in social, economic and political opportunity is disproportionately low—estimated to be near 3-5%. This has been a cause of serious concern for a long time. Though concerted efforts have been made in the past to bring about positive change, the situation remains unchanged. There are also new challenges emerging related to the image and perception of Muslims. The political agenda and issues of biases, excesses and unfairness by authorities are also reported in the media from time to time. This necessitates the need for proactive engagement with all stakeholders to create better understanding and a more socially congenial environment on one hand and policy advocacy and outreach to Government, social and political institutions.

IMPAR is pleased to announce the launch of its Business Support Platform (IBSP) for startups and small businesses. Based on the year long consultations, we realised these two areas are very important where the community needs support to realise it's potential. There is currently new wave of Startups in India and worldwide. Young people with little or no money, but with a potential idea are making big. The Startups ecosystem is also very promising today in the country. Its time for Muslim youths to tap the opportunities. They may need little guidance and initial facilitation for registration, funding, institutional linkages and validation of business models. IMPAR plans to extend the needed support and handholding. Another area that requires attention is the scaling up need of small businesses owned by Muslims. Traditionally, Muslim artisans, vendors and other small businesses have not been able to access the Government programs and schemes, and marketing, financial and institutional support system. They need guidance and facilitation to avail schemes and opportunities. Looking into this critical requirement of effective guidance, facilitation and handholding for young entrepreneurs and small businesses, IMPAR has created a 25 member expert platform with two separate groups to help the aspiring youths for Startups and small businesses to scale. IBSP is convened by Mr. Javed Yunus, India Adviser Saudi Aramco, AI and India Representative, Saudi CISP with Mrs. Shampa Siddiqui as the convenor for Startups Support Platform and Mr. Siraj Chaudhry as the convenor for Business Growth Platform.
